Dear Executive Director Thomas:

This office has received your request for a written Attorney General Opinion regarding agency actions that the Oklahoma State Board of Examiners for Long-Term Care Administrators intends to take with respect to the licensees listed in Appendix A. The Board proposes to vacate the licenses for failing to timely renew or seek reinstatement or become compliant with State income tax requirements.

Oklahoma law states that the licenses of long-term care administrators expire on the last day of December of each year and must be renewed on an annual basis. 63 O.S.2011, § 330.54. The Board's administrative rules provide that the Board "shall take formal action . . . to vacate all non-renewed licenses." OAC 490:10-3-5(f). Furthermore, certain licensees listed in Appendix A are non-compliant with State income tax requirements, and therefore, are ineligible to renew their licenses. The Board's rules require that those applying for license renewal shall "[b]e in compliance pursuant to 68 O.S. [§] 238.1 with State income tax requirements" or "such license shall not be renewed." OAC 490:10-3-5(a)(3). Several licensees who failed to renew had an "open case" at the time the licensee's license lapsed, and therefore, while the case will be closed, that licensee will be reported to the National Practitioner Data Base. The Board may reasonably believe that the proposed action will deter future violations.

It is, therefore, the official opinion of the Attorney General that the Oklahoma State Board of Examiners for Long Term Care Administrators has adequate support for the conclusion that the action advances the State's policy to require licensure of long-term care administrators.
