INFORMATION

In the name and by the authority of the State of Oklahoma, MIKE HUNTER, Attorney General of Oklahoma, in and for the State and County aforesaid, and gives the court to know and be informed as follows:

COUNT I

KEVIN CARRILLO-JARA and RAUL DOMINGUEZ-ESTRADA, acting in concert, in Tulsa County, State of Oklahoma, on or about February 2, 2020, did commit the crime of **TRAFFICKING IN ILLEGAL DRUGS**, in violation of Title 63 O.S. §2-415(B), by willfully, knowingly and unlawfully possessing an unlawful controlled drug substance, to wit: **HEROIN** in the quantities specified in Title 63 Section 2-415 (C) (2)(b), specifically not less than 28 grams of Schedule 1 Heroin of the Uniform Controlled Dangerous Substances Act of this Stat; all of which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT II

KEVIN CARRILLO-JARA and RAUL DOMINGUEZ-ESTRADA, acting in concert, Tulsa County, State of Oklahoma, on or about February 2, 2020, did commit the crime of **POSSESSION OF DRUG PROCEEDS**, in violation of Title 63 O.S. §2-503.1 to wit: cash.
