STATE OF OKLAHOMA, COUNTY OF OKLAHOMA:

In the name and by the authority of the State of Oklahoma, MIKE HUNTER, Attorney General of Oklahoma, in and for the State and County aforesaid, and gives the court to know and be informed as follows:

COUNT 1: DISTRIBUTION OF CDS NOT IN COURSE OF LEGITIMATE BUSINESS ~ a FELONY, on or between the 12th day of September, 2019 and the 13th day of September, 2019, **PATSY JANETE WISEMAN** did distribute **XANAX**, a Schedule IV controlled substance to Agent McGlasson with the Oklahoma Bureau of Narcotics, which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 2: ENDEAVORING / CONSPIRACY TO DELIVER / MANUFACTURE / POSSESS CDS ~ a FELONY, **PATSY JANETE WISEMAN** on or between the 12th day of September, 2019 and the 13th day of September, 2019, by conspiring and agreeing with **AMANDA EMHOOLAH** to commit the crime of **DELIVERING A CONTROLLED SUBSTANCE**, to wit:

METHAMPHETAMINE AND XANAX, a felony, which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 3: UNLAWFUL USE OF COMMUNICATION FACILITY ~ a FELONY, on or between the 12th day of September, 2019 and the 13th day of September, 2019, **PATSY JANETE WISEMAN** did willfully use a communication facility for the distribution and delivery of a controlled substance, to wit: **XANAX**, which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 4: MAINTAINING PLACE FOR KEEPING / SELLING CONTROLLED SUBSTANCE ~ a FELONY, on or between the 12th day of September, 2019 and the 13th day of September, 2019, did **PATSY JANETE WISEMAN** in concert with **AMANDA EMHOOLAH** did unlawfully, willfully, knowingly and intentionally, and feloniously, maintain a place of business, located at 4867 S Sheridan Road Unit 703, Tulsa, OK 74145, which place is a place resorted to by various persons whose name(s) are unknown but are persons who use controlled dangerous substances in violation of the Uniform Controlled Dangerous Substances Act of this State and who resort to said premises for the purpose of selling such substances with the knowledge of said defendants, which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 5: POSSESSION OF CDS WITHOUT TAX STAMP AFFIXED ~ a FELONY, on or between the 12th day of September, 2019 and the 13th day of September, 2019, **PATSY JANETE WISEMAN** did possess **METHAMPHETAMINE**, a controlled dangerous substance in Schedule II of the Uniform Controlled Dangerous Substances Act of Oklahoma without affixing the appropriate tax stamp.

COUNT 6: POSSESSION OF CONTROLLED DANGEROUS SUBSTANCE ~ a MISDEMEANOR, on or between the 12th day of September, 2019 and the 13th day of September, 2019, **PATSY JANETE WISEMAN** knowingly and intentionally had in defendant's possession under defendant's control **METHAMPHETAMINE**, said drug being classified as a controlled dangerous substance in Schedule II of the Uniform Controlled Dangerous Substances Act of Oklahoma, which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 7: UNLAWFUL POSSESSION OF DRUG PARAPHERNALIA ~ a MISDEMEANOR, on or between the 12th day of September, 2019 and the 13th day of September, 2019, **PATSY JANETE WISEMAN** did possess drug paraphernalia, to wit: a scale, which is used by abusers of drugs classified as Controlled Dangerous Substances and without having any medical or other lawful need requiring possession of said paraphernalia, which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 8: POSSESSION OF CONTROLLED DANGEROUS SUBSTANCE ~ a MISDEMEANOR, on or between the 12th day of September, 2019 and the 13th day of September, 2019, **PATSY JANETE WISEMAN** did knowingly and intentionally having in defendant's possession under defendant's control **MUSHROOMS**, said drug being classified as a controlled dangerous substance in Schedule I of the Uniform Controlled Dangerous Substances Act of Oklahoma, which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.
