PROBABLE CAUSE AFFIDAVIT

Your Affiant, Jessi Robertson, the undersigned, being a duly certified Peace Officer in the State of Oklahoma since August of 2014 and is currently serving as a Narcotics Agent with the Oklahoma Bureau of Narcotics and Dangerous Drugs Control (OBN), upon oath deposes and states as follows, to-wit:

Your Affiant has reason to believe that for the following period(s), June 30th, 2013 through October 20, 2016, the following crimes were committed by the above stated Defendant(s) while in Tulsa County, State of Oklahoma:

1. **Obtaining Possession of CDS by Fraud/Forgery by Registrant (one count) 63 O.S. § 2-406 (A)3.**
2. **Possession of CDS unlawfully obtained (one count) 63 O.S. § 2-402.**
3. **Conspiracy to Obtain (one count) 63 O.S. § 2-408.**

Your Affiant believes the following facts do establish probable cause that the above stated crimes were committed on the above stated dates by the above listed Defendant(s):

-During the period of June 30, 2013 through October 20, 2016 Fleckenstein did violate O.S. 63-2-408- Conspiracy to acquire or obtain possession of CDS by misrepresentation, fraud, forgery, deception or subterfuge (by his own admission to Investigator Lane and by prescribing to Lauren Oraha and Tranae Young CDS intended for himself.)

-During the period of June 30, 2013 through October 20, 2016 Fleckenstein did violate O.S. 63-2-402 (A)1-Possession of CDS unlawfully obtained (again, according to his own admittance, Fleckenstein retrieved CDS from Tranae Young and his wife after they filled the prescriptions.)

-During the period of June 30, 2013 through October 20, 2016 Fleckenstein, a registrant of OBND, did violate O.S. 63-2-406 (A)3-Acquire or obtain possession of CDS by misrepresentation, fraud, forgery, deception or subterfuge (by prescribing Lauren Oraha and Tranae Young CDS intended for himself.)

Based on this information, the undersigned believes that probable cause exists to believe that a crime has been committed and that there is probable cause to believe that the Defendant(s) above named committed that crime.
