COUNT 1: MANSLAUGHTER IN THE SECOND DEGREE, 21 O.S. § 716

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Sixteenth Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from February 27, 2017, for eighteen (18) months, or until the designated presiding judge determines the Sixteenth Multicounty Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and woman, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed and triable

within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

COUNT 1: MANSLAUGHTER IN THE SECOND DEGREE, 21 O.S. §716

On or between June 4, 2016 and June 8, 2016, the crime of **MANSLAUGHTER IN THE SECOND DEGREE** was feloniously committed in **GARFIELD COUNTY**, Oklahoma, by the defendant **JENNIFER SHAY NILES, A/K/A JENNIFER MCGLAUGHLIN**. That is to say that on or between the June 4, 2016 and June 8, 2016, Defendant **JENNIFER SHAY NILES, A/K/A JENNIFER MCGLAUGHLIN**, the Jail Administrator of the Garfield County Jail did willfully, unlawfully and without justifiable or excusable cause, caused the death of Anthony Dewayne Huff, in a culpable and negligent manner, by causing/allowing Anthony Dewayne Huff to remain in a restraint chair for over 48 hours without adequate food or water, while Anthony Dewayne Huff was in the custody of the Garfield County Sheriff's Department Jail, which caused his death on June 8, 2016, contrary to the provisions of Section 716 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.
