INFORMATION

In the name and by the authority of the State of Oklahoma, MIKE HUNTER, Attorney General of Oklahoma, in and for the State and County aforesaid, and gives the court to know and be informed as follows:

COUNT 1

JAMES MITCHELL and TYNISA WILLIAMS, in Tulsa County, State of Oklahoma, in concert with one another, on or about February 20, 2019, did willfully, intentionally, knowingly, and feloniously commit the crime of Aggravated Trafficking of a Controlled Drug Substance, Methamphetamine, **A Felony**, Title 63 O.S.§2-415(C)(4)(c), by possessing in the amount of 802.54 grams, all of which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 2

JAMES MITCHELL and TYNISA WILLIAMS, in Tulsa County, State of Oklahoma, in concert with one another, on or about February 20, 2019, did willfully, intentionally, knowingly, and feloniously commit the crime of Trafficking of a Controlled Drug Substance, Methylendioxy

Methamphetamine, **A Felony**, Title 63 O.S. §2-415(C)(8)(b), by possessing in the amount of 1,341.12 grams, all of which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 3

JAMES MITCHELL and TYNISA WILLIAMS, in Tulsa County, State of Oklahoma, in concert with one another, on or about February 20, 2019, did willfully, intentionally, knowingly, and feloniously commit the crime of Unlawful Possession of a Controlled Drug Substance with the Intent to Distribute, Heroin, **A Felony**, Title 63 O.S. §2-401(B)(2), by possessing 3.72 grams, digital scales, and “zip top” bags, all of which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 4

JAMES MITCHELL and TYNISA WILLIAMS, in Tulsa County, State of Oklahoma, in concert with one another, on or about February 20, 2019, did willfully, intentionally, knowingly, and feloniously commit the crime of Unlawful Possession of a Controlled Drug Substance with the Intent to Distribute, Marijuana, **A Felony**, Title 63 O.S. §2-401(B)(2), by possessing 1,642.24 grams, digital scales, and “zip top” bags, all of which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 5

JAMES MITCHELL and TYNISA WILLIAMS, in Tulsa County, State of Oklahoma, in concert with one another, on or about February 20, 2019, did willfully, intentionally, knowingly, and feloniously commit the crime of Unlawful Possession of a Firearm while in the Commission or the Attempt to Commit a Felony, **A Felony**, Title 21 O.S. §1287, by possessing the following: 380 Caliber Handgun, AR-15 Rifle, Beretta Handgun, AK47 Rifle, 257 Caliber Bolt Rifle, Savage Rifle, and Marlin Lever Action Rifle, while in the commission of violations of the Uniform Controlled

Dangerous Substances Act, all of which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 6

JAMES MITCHELL and TYNISA WILLIAMS, in Tulsa County, State of Oklahoma, in concert with one another, on or about February 20, 2019, did willfully, intentionally, knowingly, and feloniously commit the crime of Unlawful Possession of Drug Proceeds, **A Felony**, Title 63 O.S. §2-503.1, by possessing \$1,095 in cash, proceeds which were known to be acquired and derived from violations of the Uniform Controlled Dangerous Substances Act, all of which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.

COUNT 7

JAMES MITCHELL and TYNISA WILLIAMS, in Tulsa County, State of Oklahoma, in concert with one another, on or about February 20, 2019, did willfully, intentionally, knowingly, and feloniously commit the crime of Possession of Controlled Drug Without Tax Stamp Affixed, **A Felony**, Title 68 O.S. §450.8 (B), by possessing controlled drug substances without affixing the appropriate tax stamp, all of which is contrary to the law and the statutes, and the peace and dignity of the State of Oklahoma.
