

INDICTMENT

FOR: MAKING A FALSE, FICTITIOUS OR FRAUDULENT CLAIM, 21 O.S. § 358
(COUNTS 1-22)

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

On August 19, 2003, by order of the Supreme Court of Oklahoma entered on the 3rd day of July, 2003, the Ninth Oklahoma Multicounty Grand Jury was convened with its principal site to be Oklahoma City, Oklahoma County, Oklahoma, to serve from that date until February 20, 2005, said term of the Multicounty Grand Jury beginning on August 19, 2003, and continuing thereafter, that the said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law and then and there examined, impaneled, sworn and charged according to law to diligently inquire into and true presentment make of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath and in the name and by the authority of the State of Oklahoma, do present and find that:

COUNT 1:

On or about the 1st day of February, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between January 1, 2002 and January 31, 2002, falsely claiming that she worked a total of 168 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 48.5 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of One Thousand, Five Hundred Thirty-eight Dollars and Ninety-one Cents (\$1,538.91), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 2:

On or about the 4th day of March, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and

Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between February 1, 2002 and February 28, 2002, falsely claiming that she worked a total of 152 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 44 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of One Thousand, Three Hundred Ninety-six Dollars and Twelve Cents (\$1,396.12), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 3:

On or about the 26th day of March, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between March 1, 2002 and March 31, 2002, falsely claiming that she worked a total of 168 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 24 hours for which time

Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Seven Hundred Sixty-one Dollars and Fifty-two Cents (\$761.52), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 4:

On or about the 1st day of May, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between April 1, 2002 and April 30, 2002, falsely claiming that she worked a total of 160 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 75.75 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Two Thousand, Four Hundred Three Dollars and Fifty-five Cents (\$2,403.55), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 5:

On or about the 31st day of May, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between May 1, 2002 and May 31, 2002, falsely claiming that she worked a total of 172 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 28 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Eight Hundred Eighty-eight Dollars and Forty-four Cents (\$888.44), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 6:

On or about the 26th day of June, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and

Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between June 1, 2002 and June 30, 2002, falsely claiming that she worked a total of 128 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 8 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Two Hundred Fifty-three Dollars and Eighty-four Cents (\$253.84), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 7:

On or about the 4th day of September, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between August 1, 2002 and August 31, 2002, falsely claiming that she worked a total of 136 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 21 hours for which time

Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Six Hundred Sixty-six Dollars and Thirty-three Cents (\$666.33), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 8:

On or about the 1st day of October, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between September 1, 2002 and September 30, 2002, falsely claiming that she worked a total of 160 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 42.5 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of One Thousand, Three Hundred Forty-eight Dollars and Fifty-three Cents (\$1,348.53), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 9:

On or about the 1st day of November, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between October 1, 2002 and October 31, 2002, falsely claiming that she worked a total of 168 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 66.5 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Two Thousand, One Hundred Eleven Dollars and Thirty-eight Cents (\$2,111.38), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 10:

On or about the 4th day of December, 2002, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and

Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between November 1, 2002 and November 30, 2002, falsely claiming that she worked a total of 120 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 20 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Six Hundred Thirty-four and Sixty Cents (\$634.60), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 11:

On or about the 8th day of January, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between December 1, 2002 and December 31, 2002, falsely claiming that she worked a total of 112 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 20 hours for which

time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Six Hundred Thirty-four Dollars and Sixty Cents (\$634.60), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 12:

On or about the 4th day of February, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between January 1, 2003 and January 31, 2003, falsely claiming that she worked a total of 168 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 16 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Five Hundred Seven Dollars and Sixty-eight Cents (\$507.68), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 13:

On or about the 6th day of March, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between February 1, 2003 and February 28, 2003, falsely claiming that she worked a total of 152 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 24 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Seven Hundred Sixty-one Dollars and Fifty-two Cents (\$761.52), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 14:

On or about the 7th day of April, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and

Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between March 1, 2003 and March 31, 2003, falsely claiming that she worked a total of 168 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 60 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of One Thousand, Nine Hundred Three Dollars and Eighty Cents (\$1,903.80), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 15:

On or about the 2nd day of May, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between April 1, 2003 and April 31, 2003, falsely claiming that she worked a total of 176 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 64 hours for which time Defendant

did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Two Thousand Thirty Dollars and Seventy-two Cents (\$2,030.72), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 16:

On or about the 2nd day of June, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between May 1, 2003 and May 31, 2003, falsely claiming that she worked a total of 168 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 67 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Two Thousand, One Hundred Twenty-five Dollars and Ninety-one Cents (\$2,125.91), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 17:

On or about the 7th day of July, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between June 1, 2003 and June 30, 2003, falsely claiming that she worked a total of 168 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 63 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of One Thousand, Nine Hundred Ninety-eight Dollars and Ninety-nine Cents (\$1,998.99), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 18:

On or about the 1st day of August, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and

Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between July 1, 2003 and July 31, 2003, falsely claiming that she worked a total of 152 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 45 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of One Thousand, Four Hundred Twenty-seven Dollars and Eighty-five Cents (\$1,427.85), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 19:

On or about the 1st day of September, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between August 1, 2003 and August 31, 2003, falsely claiming that she worked a total of 168 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 34 hours for which time

Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of One Thousand, Seventy-eight Dollars and Eighty-two Cents (\$1,078.82), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 20:

On or about the 1st day of October, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between September 1, 2003 and September 30, 2003, falsely claiming that she worked a total of 168 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 63.75 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Two Thousand Twenty-two Dollars and Seventy-nine Cents (\$2,022.79), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 21:

On or about the 3rd day of November, 2003, A.D., the crime of **Making a False, Fictitious or Fraudulent Claim Against the State of Oklahoma** was feloniously committed in Oklahoma County, Oklahoma, by the Defendant, GENEVA FAYE WORTHEN, who is also known as GENEVA FAYE DeHART, FAYE WORTHEN and FAYE DeHART. That is to say that the aforesaid defendant was employed by the Oklahoma Center for the Advancement of Science and Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between October 1, 2003 and October 31, 2003, falsely claiming that she worked a total of 158.5 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 29 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Nine Hundred Twenty Dollars and Seventeen Cents (\$920.17), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.



Technology (OCAST), an agency of the State of Oklahoma, and did then and there, and within said County and State, knowingly, willfully and feloniously make and present, or cause to be presented, to OCAST a false, fictitious, or fraudulent claim for the payment of salary to be paid from public funds for the time period between November 1, 2003 and November 30, 2003, falsely claiming that she worked a total of 86.5 hours during the aforesaid time period when in truth and fact said Defendant was absent from work during the aforesaid time period for a total of 21.5 hours for which time Defendant did not claim any form of authorized leave, resulting in an overpayment of Defendant for said period in the amount of Six Hundred Eighty-two Dollars and Twenty Cents (\$682.20), and said false, fictitious or fraudulent claim being thereafter paid in full with public funds belonging to the State of Oklahoma, contrary to the provisions of Section 358 of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.
