

narcotics for. Her boyfriend Dale Markus another was his roommate Chris Maple and a third was Kyle Hurst.

Markus usually requested the narcotics for Hurst. However on occasion Hurst would contact Alexander and place an order for the type of narcotic he wanted to purchase from her. Alexander would then take the controlled dangerous substance from the crescent care center. Alexander would contact Hurst and arrange for delivery.

Alexander said the reason she took the narcotics was, for her boyfriend and his roommate to sell, and for their personal use. Markus would sell the narcotics to pay for his child support when he was unemployed. This went on for three or four months, she would randomly take narcotics that were supposed to go to residents.

Alexander went on to explain that over the time period from August of 2011 to February of 2012 she took several cards of Lortab, Dilaudid and Xanax. Each card contained approximately 60 pills each. She would give the cards to her boyfriend at the time, Dale Markus, who would then either sell the pills or give them to Chris Maple for him to sell or use. She was not clear on how many narcotics she took during the time period.

The Pharmacy used to provide medications/narcotics to Crescent Care Center was Pharmacy Solutions located in Oklahoma City, OK. Another method Alexander used was to take the narcotics at the time they arrived from Pharmacy Solutions, Because she was the Certified Medication Aid she could request narcotics from the pharmacy for resident's that had prescriptions. She would then be the one to receive the narcotics from the pharmacy.. She said a shipment would come in from pharmacy. If they sent three cards for PRN (as needed), she would make the count sheet for two cards instead of three and take one. She would then make out a count sheet for each card that came in. If she kept a card she did not make a count sheet for that card. She did not know how many times she did this. She again explained that it happened so many times she does not know how much she took. Alexander was asked how/why she began taking cards. Alexander was asked how she got the narcotics out of the home. She said she usually carried a large bag with her and she would place the cards in the bag and take it out to her car.

Dale Markus was interviewed by investigators concerning the theft of Narcotics. He recalled dating Alexander in August of 2011. He said she worked at the Crescent Care Center and he had heard she was giving narcotics to Kyle Hurst. Alexander began providing him with narcotics that she took from the Crescent Care Center. He knew this because some of the narcotics were still in the packaging (bubble pack) from the home. Markus said she provided approximately 100 Dilaudid pills, 500 Hydrocodone (Lortab), Liquid Morphine one bottle, 300-400 Xanax (Alprazolam) pills and approximately 30 Fentanyl patches (Durogesic/Duragesic/Matrifen).

Chris Maple was also interviewed and corroborated the testimony of


Markus. He stated that he also received narcotics from Alexander and he observed her to give narcotics to Markus.

The pharmacy logs and resident's narcotic logs were reviewed. It was discovered that Jodi Alexander did sign for a substantial amount of narcotics arriving from the pharmacy however the records were inconclusive as to whether the narcotics were logged or taken. Alexander did have access to the medication cart and the resident's narcotics.


Based on Alexander's statements as well as the witness statements it is believed that Alexander did take the following Controlled Dangerous Substances: Dilaudid, Hydrocodone (Lortab), Liquid Morphine one bottle, Xanax (Alprazolam) and Fentanyl patches (Durogesic/Duragesic/Matrifen).

I request, upon probable cause, the court issue a warrant for the arrest of Dale Steven Markus on the charge Distribution of a Controlled Dangerous Substance 63 O.S. § 2-401 (A) (1).
