INDICTMENT

FOR: KNOWINGLY CONCEALING EMBEZZLED OR STOLEN PROPERTY,
21 O.S. 2001, § 1713 [1 Count, being primary and alternate Count 1]

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Thirteenth Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from February 22, 2011 until August 22, 2012 or until the designated presiding judge determines the Thirteenth Multicounty Grand Jury has reached reasonable completion of its investigations, but in any event, no more than twenty-four (24) months from the commencement of its term. That the said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and woman, legally drawn and summons according to law and then and there examined, impaneled, sworn and charged according to law to diligently inquire into and true presentment make of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath and in the name and by the authority of the State of Oklahoma, do present and find that:

COUNT 1: FOR KNOWINGLY CONCEALING EMBEZZLED PROPERTY

During a time period commencing upon an unknown date, but including the period from September 7, 2010, through and including the 21st day of December, 2011, the crime of **Knowingly Concealing Embezzled Property** was committed in Pittsburg County, Oklahoma by the defendant, **ANGELA MARIE MARCUM, a.k.a., ANGELA MARIE TARRON**, together with another person. That is to say that within said time period, and within the aforesaid County and State, the said Defendant was the former Drug Court Coordinator for the District 18 Drug Court Program serving Pittsburg County and McIntosh County, Oklahoma, the same being a public agency of the 18th Judicial District, State of Oklahoma, and who was under investigation by the Oklahoma State Bureau of Investigation, the Office of State Auditor and Inspector, and the Thirteenth Multicounty Grand Jury and the subsequent *Indictment* of said grand jury upon the offenses of **Embezzlement of Public Money, Embezzlement of Public Property, and Stealing or Concealing Public Records**. That also within said period and within said County and State, the Defendant, aided by another person during a portion of said period, did knowingly, willfully, intentionally, and feloniously conceal and withhold certain personal property consisting of original business records belonging to District 18 Drug Court, the same being original District 18 Drug Court participant records for the following Drug Court participants, *to-wit*: Heather Lester, Jason Cox, Jonathan Dalpaos, Brandi Gray, Cara Hafeman, David Henry, Shonda Huddleston, Krystal Johnson, Amy James, Wacey Nowlin, Brian Wiley, Eugene Tilman, III, and Jarred Polansky, knowing the same to have been embezzled from District 18 Drug Court, and with the intent to permanently deprive District 18 Drug Court of said property; all of the foregoing acts being committed in violation of Section 1713 of Title 21 of the Oklahoma Statutes and against the Peace and Dignity of the State of Oklahoma.

Or, Alternatively,

ALTERNATIVE COUNT 1: FOR KNOWINGLY CONCEALING STOLEN PROPERTY

During a time period commencing upon an unknown date, but including the period from September 7, 2010, through and including the 21st day of December, 2011, the crime of **Knowingly Concealing Stolen Property** was committed in Pittsburg County, Oklahoma by the defendant, **ANGELA MARIE MARCUM, a.k.a., ANGELA MARIE TARRON**, together with another person. That is to say that within said time period, and within the aforesaid County and State, the said Defendant was the former Drug Court Coordinator for the District 18 Drug Court Program serving Pittsburg County and McIntosh County, Oklahoma, the same being a public agency of the 18th Judicial District, State of Oklahoma, and who was under investigation by the Oklahoma State Bureau of Investigation, the Office of State Auditor and Inspector, and the Thirteenth Multicounty Grand Jury and the subsequent *Indictment* of said grand jury upon the offenses of **Embezzlement of Public Money, Embezzlement of Public Property, and Stealing or Concealing Public Records**.
