**INDICTMENT**

***FOR: HARBORING A FUGITIVE, 21 O.S. §440 [1 Count being Count 1]***

*IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:*

By the order of the Supreme Court of Oklahoma, the Fourteenth Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from February 25, 2013 until August 25, 2014, or until the designated presiding judge determines the Fourteenth Multicounty Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That the said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and woman, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into and true presentment make of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath and in the name and by the authority of the State of Oklahoma, do present and find that:

**COUNT 1: HARBORING A FUGITIVE**

On and/or about the 17<sup>th</sup> day of October, 2012 through the 12<sup>th</sup> day of December, 2012, the crime of **Harboring a Fugitive** was committed in **LINCOLN COUNTY, OKLAHOMA**, by the Defendant **SHANDA LYNN CHASTAIN**. That is to say, on and before said dates, inclusive, the Defendant **SHANDA LYNN CHASTAIN** was employed as a legal assistant to **Co-Defendant CRAIG S. KEY**, an attorney engaged to provide legal representation to Brandon Ray Dawson in CF-2012-288 (Lincoln County, Oklahoma), **Knowingly Concealing Stolen Property, Possession of Firearm After Former Conviction of a Felony, and Possession of Controlled Dangerous Substances**; CF-2012-133 (Lincoln County, Oklahoma), **Possession of Controlled Dangerous Substances**; and CF-2012-33 (Jefferson County, Oklahoma), **Knowingly Concealing Stolen Property**. That the aforementioned Brandon Ray Dawson did on the 17<sup>th</sup> day of October, 2012 and the 9<sup>th</sup> day of November, 2012 and the 6<sup>th</sup> day of November 2012, respectively, become a fugitive from justice by failing to appear in the District Courts of Lincoln and Jefferson Counties, Oklahoma, resulting in felony arrest and bench warrants being issued for his arrest, instead traveling to the States of Kansas, New Mexico, and ultimately Alaska for the purpose of avoiding prosecution for the aforementioned offenses. That the Defendant, **SHANDA LYNN CHASTAIN, acting conjointly with Co-Defendant CRAIG S. KEY**, did knowingly provide encouragement, aid, assistance and concealment for Brandon Ray Dawson by providing him with money for hotel rooms, food, airplane tickets and incidental living expenses allowing Brandon Ray Dawson to flee the State of Oklahoma to avoid prosecution to remain a fugitive from justice on the aforementioned charges and outside the State of Oklahoma. All of

said acts being contrary to the provisions of Sections 440 of Title 21 of the Oklahoma Statutes and against the Peace and Dignity of the State of Oklahoma.
