FOR: MURDER IN THE FIRST DEGREE, 21 O.S. § 701.7(A), [1 Count, being Count 1]

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:


By the order of the Supreme Court of Oklahoma, the Thirteenth Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from February 22, 2011 until August 22, 2012, or until the designated presiding judge determines the Thirteenth Multicounty Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That the said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and woman, legally drawn and summons according to law and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into and true presentment make of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath and in the name and by the authority of the State of Oklahoma, do present and find that:

COUNT 1: MURDER IN THE FIRST DEGREE

On or about the 26th day July 2003, the crime of **Murder in the First Degree** was committed in Pawnee County, Oklahoma, by the Defendant **Amanda Sanders-Bolstad**. That is to say the said defendant, on or about the 26th day of July, 2003, and in the County and State aforesaid, then and there being, with malice aforethought, and the deliberate intention unlawfully to take away the life of a human being, did then and there willfully, unlawfully and feloniously, without authority of law, effect the death of Heath Riley Reams by striking him with a baseball bat, then and there and thereby inflicting certain mortal wounds in the body of said Heath Riley Reams, from which mortal wounds the same did languish and die on or about the 26th of July, 2003, in violation of Title 21 OSA, Section 701.7(A), contrary to the form and the statute in such case made and provided and against the peace and dignity of the State of Oklahoma.
