### Annual Report of Private Attorney Contracts

Fiscal Year 2014



The Oklahoma Office of the Attorney General is required by Title 74, Section 20i(G) of Oklahoma Statutes to produce a written report on the private legal representation obtained by state agencies. This report is to include a brief description of each contract, the circumstances necessitating each contract, and the amount paid under each contract.

The Attorney General has made it a priority to reduce the amount of taxpayer dollars spent on private attorney contracts by increasing the number of state agencies the office represents through the General Counsel and Litigation units of the office. Again this year, our efforts have paid off as over \$200,000 was saved on contracted expenditures. The Attorney General has reduced spending on private attorney contracts by \$4.59 million during his first term.

The goal of the Attorney General is to continue bringing more legal representation into the office thereby reducing taxpayer dollars spent on legal representation, increasing accountability for the legal work performed on behalf of Oklahoma, and enhancing the oversight of the legal services that the Attorney General's Office is providing. This year, as the data for the report was collected, we received information from various agencies that moneys had been spent on private attorney contracts even though the approval process had not been utilized. With this information in mind, the Office of the Attorney General will continue to work with the various state agencies, boards, colleges and universities to not only provide legal services on behalf of the State of Oklahoma but also do so in the most cost effective manner.

The Attorney General is pleased to present all reported private attorney contracts obtained during the Fiscal Year 2014 for your review.






