- COUNT 1: AGGRAVATED MANUFACTURING OF A CONTROLLED DANGEROUS SUBSTANCE, TO WIT: MARIJUANA, 63 O.S. § 2-401(G), a FELONY**
- COUNT 2: AGGRAVATED TRAFFICKING OF A CONTROLLED DANGEROUS SUBSTANCE, TO WIT: MARIJUANA, 63 O.S. § 2-415, a FELONY**

*IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:*

By the order of the Supreme Court of Oklahoma, the Twentieth Multi-County Grand Jury of Oklahoma was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from June 27, 2023, for eighteen (18) months, or until the designated presiding judge determines the Twentieth Multi-County Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multi-County Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed

and triable within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

**COUNT 1: AGGRAVATED MANUFACTURING OF A CONTROLLED DANGEROUS SUBSTANCE, TO WIT: MARIJUANA, 63 O.S. § 2-401(G), a FELONY**

On, about or between November 7, 2023 and November 9, 2023, the crime of **AGGRAVATED MANUFACTURING OF MARIJUANA** was committed by **BOBBY LEE HAILEY** who produced, prepared, propagated, compounded and/or processed a controlled dangerous substance, to wit: marijuana at Gonnabe Ranch, 17774 HWY 104, Wagoner County, Oklahoma in the amount of one thousand (1,000) or more kilograms or more of a substance containing a detectable amount of marijuana, a Schedule I controlled dangerous substance, contrary to the provisions of Section 2-401(G) of Title 63 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

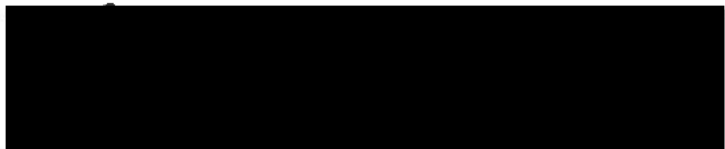

**COUNT 2: AGGRAVATED TRAFFICKING OF A CONTROLLED DANGEROUS SUBSTANCE, TO WIT: MARIJUANA, 63 O.S. § 2-415, a FELONY**

On or about November 9, 2023, the crime of **AGGRAVATED TRAFFICKING OF MARIJUANA**, a controlled dangerous substance, was committed by **BOBBY HAILEY** who possessed in excess of one thousand (1000) pounds of marijuana, a Schedule I controlled dangerous substance, at a barn located at the southeast corner of the intersection of North 4160 Road and East 850 Road, Wagoner County, Oklahoma, contrary to the provisions of Section 2-415(C)(1)(b) of Title 63 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.
