Latimore, Marquetta	Abuse by Caretaker 21 O.S. 843.1	While working at South Park East Nursing Facility, Latimore witnessed a head injury and failed to provide care. After a resident sustained laceration to the back of her head, Latimore placed the resident back in bed and placed a pillow case under the injury but did not provide any medical care. Brown, Cecilia	Abuse by Caretaker 21 O.S. 843.1	Brown worked for Reliant Living Center, a facility for developmentally disabled adults. While there Brown engages in an altercation with a resident that results in Brown dragging the resident across the room and attempting to strike him.	February 21, 2020	Caretaker	Oklahoma
Warner, Veronica	Abuse by Caretaker 21 O.S. 843.1	Warner worked as a charge nurse for Edwards Redeemer. After the resident was transported back to the facility from the hospital, he had an incident of incontinence and notified Warner. Warner did not provide care for the resident and he was left sitting in waste for over four hours causing skin injuries.	March 04, 2020	Caretaker	Oklahoma
McAlister, Toni	Financial Exploitation by Caretaker 21 O.S. 843.4	McAlister worked in the business office of the Southern Hills Rehabilitation Center where she was responsible for receiving payments for residents' board and care. McAlister also managed the trust accounts for discretionary spending. McAlister siphoned off funds from the trust accounts as well as embezzling the funds paid directly from residents or their families.	June 24, 2020	Caretaker	Tulsa
McAlister, Toni	Financial Exploitation by Caretaker 21 O.S. 843.4	Following her termination from Southern Hills, McAlister worked as the Business Office Manager at Wood Manor Nursing Center where she was responsible, in part, for management of the trust accounts for discretionary spending. McAlister used these funds for her own personal gain.	June 24, 2020	Caretaker	Rogers

West, Honey	Neglect by Caretaker 21 O.S. 843.1	West was working as a Licensed Practical Nurse at the University Village Retirement Center.
